PREFACE.

My presentation of the subject carried with it no special qualifications for the task undertaken. I have simply attempted to give an account of the Zink family in America. Persistent effort has been made to collect the facts set forth. County, town and church records have been searched. Histories, genealogies and other sources of information have been freely consulted and every Zink whose address was known or could be obtained was written to unless his record had already been secured.

Although no effort has been spared to make this Genealogy complete, the migratory habit has made it difficult and sometimes impossible to secure the complete and adequate record of this sturdy race of men and women who underwent the trials and privations of the pioneers of our country.

It is an established principle that to interest others, one must himself be interested and being a Zink is my excuse for attempting this work and I have found it fascinating; nevertheless, mere enthusiasm on the part of the compiler will not produce a genealogy and one needs the assistance and encouragement of the whole family whose records he tabulates.

I have had their support and I desire to place on record my thanks to the Zink family individually and collectively and more especially to Mrs. Zella W. Atkinson and Mrs. Jessie Polk Zink, but for whose encouragement in the early part of the work, I would have weakened and given up.

Also to Mrs. Sarah McClure Zink of Hillsboro, O. and Mrs. Eva Foy O'Gorman of Washington D. C. who secured much valuable data for me.

Mrs. Atkinson furnished the material for Chapter one and of that part, the Seaton data was checked by E. W. Seaton of Martinsville, Ill. and the Martin data by Alonzo E. Martin of West Liberty, Ill. Joseph Perisho data by E. E. Perisho of Streator, Ill. brought to date by Mrs. Josephine (Zink) Cornwell of Paris, Ill. Mrs. Zink secured all the data of her husband's family.

I have been asked about Heraldic rights and I was informed by a Heraldic artist that there exists a Zink coat of arms, but my research work did not discover any of the necessary information that entitled us to such decoration. Our people seem to have avoided the pretentious thoroughfares and been content with the quiet life and green fields that lead to the door of the

vine clad cottage. Heraldic devices are not the only marks of family worth and the Zink family may well be proud of at least two of the family characteristics which entitle it to distinction—its patriotism and remarkable freedom from crime.

There has never been a war in our country in which the Zinks have not borne an honorable part. With its men self-reliant and law-abiding and its women conspicuous for all the womanly virtues, can we fail to be proud of our connection with the family?

I have placed the incomplete "sections" at the end of the work in the hope that some one more fortunate than I have been, will be able to supply the links that will connect them with their proper line of descent. In the meantime I shall continue to search for the missing Zinks.

Errors will unavoidably creep into a work of this kind, but it is my hope that the Genealogy as a whole, may favorably commend itself to the Zink family.

Each name presented is printed in capitals, preceded by an indentifying number and followed by a superior figure giving the generation of the person, beginning with the earliest that we have secured.

The name and number enclosed with the () is the Zink parent.

The historical data of each person is followed by a list of his children in which each child is given a number. Where the number is preceded by — it indicates that that number is dropped.

The other numbers will be found farther on continuing the family record.

Some data was received after the work was assembled. As far as possible it was placed where it belonged but not numbered. Some had to be placed at the end of the work. All names will be found in the index. Each chapter contains a family group.

INTRODUCTION

ZINK

The name was spelled variously by the emigrants who came from Germany, Austria & Holland. Zink, Zincke, Zinch and Sinks were the common spellings but a few more consonants were added to some that I presume were the same name.

Because my father claimed that his early ancestors spelled the name Zinck and most of the younger ones spelled it Zink, while a few used Sink, I have considered that these spellings belonged to the same root and have tried to trace them, but the Sink people have not responded to inquiries and some of the Zincks were likewise unresponsive.

Most of the Wills that I have quoted and many property transfer signatures were written in German and were translated in the Court records which are assumed to be correct as is also the statement that the names Cudlip & Godlove are just different translations of the name Gottlieb.

The Zink family is of ancient and distinguished lineage in Germany. It is noted for the number and prominence of physicians & surgeons.

Both Dr. Philip Zink & Dr. Charles Edwir Zink, were physicians to King Maximilian II of Bavaria.

After the Revolutionary War we find Gottlieb Zink and his family in Virginia. He and Rosanna, his second wife, are living on a plantation in Washington County, near Abingdom, Virginia, when Gottlieb made his will, (dated 12-28-1801.) His son, Daniel, was made administrator, 12-21-1802. The Plantation is on the Holstein River, Washington County, Viirginia.

CHAPTER I

First Generation

Will of Gottlieb (Godlieb) Zink:

Will Bk. Abingdom, Virginia. In the name of God, Amen. I, Gottlieb Zink, of Washington County, Virginia, being old but thanks be to God of sound mind and memory and having taken into consideration the mortality of mankind, make herewith my last will and testament as followeth, principally I recommend my soul into the hands of my Creator, to be in mercy recorded thru the merits of my Redeemer, Jesus Christ, and my body I give unto earth to be buried in a Christian manner and in full hopes of joyful resurrection. And touching my wordly estate where with it pleased God to help me with, I give and bequeath as herewith following: 1st—I give and bequeath unto my beloved wife, Rosanna, the mare which she brot to me or the worth thereof, together with all her clothes and what belongs to the covering of her body; and also as long as she does remain my widow, she shall have the seat in the house we at present live together in, with all the rent-charge which my son, Daniel, was held to give unto my first wife (his mother) in a written contract between me and him. Further my said beloved wife, Rosanna, shall have a right to my bed and all my kitchen and household furniture and all my personal estate for her use as long as

she lives or remains my widow and all this as hereinafter shall be ordained.

Item:

I give and bequeath unto my loving son, Daniel, the plantation on which I now live with all its appertenances to have and to hold unto him, his heirs and assigns, with this express reserve that my widow, Rosanna, shall have the same liberties and privileges thereon, as his Mother might have had according to our said written contract. And should my said widow, Rosanna, choose to remove from her said seat, the four impartial men chosen by both parties are to assess and confirm what shall be paid unto her yearly, in quarterly or half yearly payments in cash— as long as she shall remain my widow. And futhermore my son, Daniel, shall pay unto my other children, namely; Peter Zink, Jacob Zink, and my daughters, Catherine Brock, Elizabeth Weaver and Fronica Rush or their heirs, the consideration money mentioned in our said written contract and no more.

In witness where of I have here unto set my hand the 26th day of December, 1801. Witnesses, Nathaniel Lewis, Jacob Cole, Benjamin Spyker.

At a court held for Washington County, Virginia, 12-21-1802 Daniel Zink, Administrator and on his bond, David and Robert Craig—security \$2000.

Will written in German, translated by Benjamin Spyker and Michael Shugart, appointed by Court. Will proven by oaths of Nathaniel Lewis, Jacob Cole, Benjamin Spyker, the subscribing witnesses.

Written contract referred to, never located, perhaps burned by the fire which destroyed the first Abingdon, Virginia Court House (Washington County, Virginia).

Deed Book 2, Page 548, tells of John Funkhouser and wife, Eleanor, selling to Gottlieb Zink two tracts of land, 6-18-1802, namely; 260 acres. The Gottlieb Zink will gives this land to Daniel Zink and Deed Book 3, Page 349, tells of Daniel Zink and wife, Elizabeth, selling to Jacob Shetter one tract of land, 5-21-1805. Deed Book 3, Page 508, tells of Daniel Zink and wife, Elizabeth, selling a second tract of land to Peter Minick, 12-10-1806.

Daniel signs in 1806, but Elizabeth did not, therefore, at a court held in Washington County, Abingdon, Virginia, October 15, 1811, the foregoing Indenture of bargain and sale was ac-

knowledged by Elizabeth Zink-she having been first privily examined a law directs.

(4) a lady he met on a steamboat trip and it was of short duration. m. (5) Margaret Stivers 2-20-1834 in Edgar Co., Ill. by James Adams, and this elderly couple separated because of old age, each going to live with their respective children. Daniel lived with his daughter Susan Zimmerly, who also cared for his youngest son Andrew F. Zink born to the third wife Elizabeth Cline. Polly, a defective child, was cared for by Elizabeth Archer.

Will of Daniel Zink:

Page 127, Will Book, Edgar County, Illinois, at Paris, Illinois. I, Daniel Zink, of County of Edgar, Illinois, do make-ordain-publish this my last will and testament in manner and form following, that is to say:

1st, I will all my just debts to be paid by my executor hereinafter named.

2nd, I will to John C. Archer as the Trustee of my daughter, Polly, my cow which I now own if said cow shall be alive when I die and \$30 out of my money that may come to the hands of my executor, not necessary to the support, clothing and education of my son, Andrew F. Zink, to be by said Archer applied to said Polly's support.

3rdly, I give and bequeath to my son Andrew F. Zink, the west one-half of the Northwest Quarter of Section 15, containing 80 acres; the Southwest Quarter of Southwest Quarter of Section 15, containing 40 acres and the West one-half of the Northeast Quarter of Section 28 containing 80 acres, all in Township 13, North of Range 12 West, in County of Edgar and State of Illinois. All of said lands I deeded to my son Andrew F. Zink 4-28-1841, which deed is now on file in the Recorders Office in said County. This item is here inserted to aid the claim if any aid is wanting to my said son's title to the above described lands, the said lands having been purchased by me with money I received by his late mother, Elizabeth Zink, formerly Elizabeth Cline.

4thly, I authorize my executor to keep and preserve for my son, Andrew F. Zink, all my tools of every description, including my wagon, harrow, log chain, and half bushel.

5thly, I authorize my executor hereby to sell all or any of the personal property, which I may be possessed of at my death, unless said executor shall believe it more to the interest of my son, Andrew F. Zink to withdraw any of said property from sale after the same has been duly offered at sale and fails to bring a reasonable price. Any article offered for sale and not sold may be preserved for my said son or sold afterwards if a fair price can be gotten for it.

6thly, I will that my farm be rented out on the best terms to be had, restricting the tenant and all others not to cut or injure any green timber on same and prohibiting any stock from running in the apple orchard at any time.

I appoint my friend, Jacob Zimmerly, Sr., sole executor of this my last will and testament. In witness whereof I have here unto set my hand and seal this 5-18-1841.

Codicil to last will and testament of Daniel Zink:

I hereby give and bequeath to my son, Andrew F. Zink, all the estate, real and personal of which I may die seized and possessed except so much there of as will pay my debts and the legacy in this my last will here preceding, given to John C. Archer as Trustee of my daughter Polly Witness my hand and seal 5-25-1841.

in Paris, 8-11-1841—present Samuel Connely, P. J. P. This day the last will and testament of Daniel Zink, deceased, was produced in open court and proven by oaths of Jonathan Mayo and Andrew Cline, the subscribing witnessess hereto, in due form of law and ordered to be recorded. And at the same time a codicil to the last will and testament of Daniel Zink, deceased, was produced in open court and proven by oaths of George Rhôdes and Isaac Zimmerly, the subscribing witnesses thereto in due form of law and also ordered to be recorded.

He was a son of James Seaton b. in Ireland 1718 and Elizabeth Robinson, who were married in Andover, Mass. 5-5-1748, and grandson of John Seaton, born in Scotland, and Jane Edwards who were married in Scotland, but moved to Ireland, had their family there and about 1729 emigrated to America with their seven children, settling in Essex Co., Mass. Barbara Ellen Zink m. (2) in Washington Co., Ind. spring of 1814 to Joseph Perisho, b. 12-27-1786, d. 4-23-1838 son of Joseph Perisho who was born in France about 1740, said to have been a sailor who was shipwrecked and landed at Edenton, Chowan County, N. C. (Albemarle Sound previous to 1780). There he married Nancy Saunders and remained the rest of his life, operating a grist mill. They had 3 sons, Seth died young. Joseph, and John. Joseph and Barbara E. Perisho moved from Monroe Co., Ind. to Paris, Ill. in 1825.
